# MINUTES OF THE REGULAR MEETING OF THE CANTON TOWNSHIP BOARD OF TRUSTEES HELD TUESDAY, JANUARY 26, 2016

The Canton Township Board of Trustees met in a Regular Session on Tuesday, January 26, 2016 with Trustee Mittas, Trustee Nichols, and Trustee Smith present.

### **MEETING MINUTES:**

### Regular Meeting – December 29, 2015

Mr. Mittas made a motion to approve and waive the reading of the minutes from the December 29, 2015 Regular Meeting. Motion seconded by Mr. Nichols and voting YES – Mr. Mittas, Mr. Nichols and Mr. Smith.

### Regular Meeting – January 26, 2016

Mr. Mittas made a motion to approve and waive the reading of the minutes from the January 26, 2016 Regular Meeting. Motion seconded by Mr. Smith and voting YES – Mr. Mittas, Mr. Nichols and Mr. Smith.

#### **PUBLIC SPEAKS:**

# Tracy Smith – Co-Owner of Meta Waste – 228 – 4th Street, NE

Tracy stated that they did not bid on the contract because they cannot afford to supply carts and bond. She also stated that the opt-out will not work for them because they will have to drop their prices to compete. Their business supports their family and Canton Township is a big part of their business.

### David Smith – Co-Owner of Meta Waste – 228 – 4th Street, NE

David stated he appreciates the township's position but at the last meeting he mentioned the weight of the larger trash trucks. He would like to know if by saving a little bit of money will there be another road levy to fix the roads. He has spoken with residents from Canton Township and they are upset you are telling them who their trash service has to be. Is asking that you really weigh your decision, it not only affects them if affects their employees.

# Mark Scherball – 4617 Wiseland SE

Mark questioned why the Township is doing this. Does not know about anyone else but his trash hauler picks up anything year round. Doesn't have to wait until Spring and then there's a mess.

# Wilbur Kinney – 4601 Wiseland Ave SE

Why was this hidden in the newspaper if you wanted to hear from people. He wasn't asked if this is what he wanted. He stated that he didn't know about it until Meta Waste contacted him and told him. If you would put down better roads maybe this wouldn't be a problem.

## Bethel Baptist Church – 1135 Churchmont Street SE

Kenstar has picked up their trash for ten years and he is reasonable and would like to keep him. Members of his church are happy with Kenstar and would not want anyone else. Would like to get a petition to stop this contract. How many signatures does he need?

# Charles W. Shaheen – 2435 – 14th Street SE

Has had Kenstar for six years and he is reliable and gives him a senior citizen discount.

### Fred Masters – 4521 Monica Ave, SW

The county is more concerned with the weight of the trucks and not the amount of trucks. Just wanted to say that 19% of the people trusts the government to do the right thing. Likes this community and thinks the trustees do a good job and hopes that you will do the right thing.

### Sharon Ross – 4538 Monica Ave, SW

Believes that this feels like she is being controlled and it doesn't feel right. Believes she should have whomever they want and not be controlled. Does not think it is right to proceed with this.

# Derrick Kuberacki – 4105 Cleveland Ave SW

Thanked the trustees for trying to find ways to cut costs. He is a small business owner. Would like to put out to the big companies to put out their best price instead of going into contract.

#### Mike Bagley – 4610 Sandy Ave SE

Supports small business and supports Kenstar and he registered to vote when he was a junior in high school. Elected officials are put into place to protect the community. He wants to keep the small businesses in Canton Township.

### David Lambert - 3929 Navarre Rd SW, Lot #8

Would like to discuss the ordinances and resolutions. Stark County Sheriff informed him on Saturday that they do not have any control and they are badly written and they cannot enforce them. Did not know how to approach this or how to handle this.

#### Carol Neal - 3924 Navarre Rd SW

Her issue is there is a lot of noise and a lot of trash thrown around. She is speaking about The Cove bar. There are broken bottles laying around and something is going on over there. The bar should be closed but they are open still at 3:00 a.m. If there is something that can be done she would appreciate it.

Mr. Nichols made a motion to approve the Fire Chief to contract with Dolphin Electric, Inc. for the purchase and installation of a natural gas generator at Station 2 with a cost not to exceed \$8,975.00. Motion seconded by Mr. Mr. Smith and voting YES – Mr. Mittas, Mr. Nichols and Mr. Smith.
