Yard Waste Update

We could use your help and vigilance in keeping costs in check!

If you utilize the Yard Waste Site and see any of the items pictured occurring, please relay the time and day so video recordings and card gate access records may be reviewed.

♻️ Card sharing with other households is prohibited

♻️ Utilizing dump trucks and dump trailers is prohibited

♻️ Dropping off oversized or prohibited yard waste violates your agreement for access

Decades of grant subsidized funding of Canton Township's Yard Waste Site

operation (having allowed access to remain free) ended with 2024 marking the first year of privatized operation. After final set-up investment, user fees fund operations. The township General Fund is not a funding source for this operation.

A best guesstimate of the number of passes that may be sold combined with average use of the site and related hauling/administrative costs resulted in a \$40/pass first year user fee. Following review of current container run rates, it is becoming evident usage is likely to exceed and possibly far exceed user fee revenue by conclusion of the year. To that end, Canton Township remains committed to doing everything possible to control costs and this includes revoking access for anyone not abiding by the terms and conditions agreed to.

More importantly, eliminating prohibited usage this year will help the township establish a more accurate and expense offsetting card access pass fee for 2025.

Public Works Department

The Board approved a product purchase recommended by the Public Works Department intended for coating brick surfaces that will help thwart graffiti in

an amount not to exceed \$1,400 from Phipps. The product will be applied to all new structure brick at Faircrest Park.

Zoning Department

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87.4. 5213 Ridge Ave SE, 4204 Dueber Ave SW, 518 Aultmont Ave NW , 1125 Brant Ave NW for trash and debris. 4003 4th St NE for tires, 615 Carrolldale Ave SE for unsecure structure.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on (17) parcels 1302820, 1312336, 1380055, 1380056, 1305244, 1304876, 1304875, 1303300, 1303301, 1302764, 1305576, 1307734, 1305099, 1303096, 1301441, 1400626 and 1307798 totaling: \$8,650.00

As of the 6/18 meeting, 153 letters have been sent for high grass nuisance notification. The township has mowed 41 properties. An assessment is then placed on the tax duplicate.
