

# January 4th Meeting Highlights

#### General News

During the recent Reorganizational Meeting, the Board of Trustees appointed Christopher Nichols as Board President and Keith Hochadel as Vice President for 2023.

## Fire Department

The Board took steps for placement of a fire levy on the May ballot. The department continues operating with funding levels established a decade ago while department member compensation, need for full squad replacement, and other capital needs must be addressed.

## **Public Works Department**

The Public Work Director provided an update regarding 2022 winter snow/ice road maintenance. Crews have been out on six occasions with a total cost of approximately \$79,000 (this includes labor, equipment, salt/materials).

The Board approved a quote from Southway Fence Company for \$14,550 to install 300 feet of guardrail along Central Ave SE just south of Faircrest St along the creek. The Public Works Department will be assisting Southway with traffic control during installation.

## **Zoning Department**

The Board of Zoning Appeals will conduct a public meeting to consider the following appeals:

- 2850 Waynesburg Dr SE- Parcel No. 1380057- RR- Rural Residential. Applicant is seeking a conditional use permit to operate a child daycare inside of a church building in a RR- Rural Residential District per subsection 153 of Article VIII. This property is located in the Northeast Quarter of Section 23 in Canton Township, Stark County, Ohio.
- 3423 39<sup>th</sup> St SW- Parcel No. 1308229- RR- Rural Residential. Applicant is seeking a (5) foot variance to the west side yard setback to build an addition to the primary residential structure. This property is located in the Northeast Quarter of Section 30 in Canton Township, Stark County, Ohio.
- 1433 W. Valentine Cir NW- Parcel No. 1401037- RR- Rural Residential. Applicant is seeking a conditional use permit to operate a short-term rental in a RR- Rural Residential District. This property is located in the Northwest Quarter of Section 5 in Canton Township, Stark County, Ohio.

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for nuisance abatement on (1) parcel: 1315065 totaling \$3,379.00.
