Public Works Department

The Board approved a resolution to designate temporary "No Parking" zones on the following roads for Community Day on June 26th from 8:00 a.m.- 11:00 p.m.:

39th Street SW (Highview to road dead end)

The Board approved a resolution to designate temporary "No Parking" zones on the following roads for the Pro Football Hall of Fame Festival, from Thursday, August 5th at 9:00 a.m. through Sunday, August 8th at 10:00 p.m.:

Helen Place NW (Lakeside to Clarendon),

Clarendon NW (Helen Place to 17th Street),

17th Street NW (Clarendon to Broad),

16th Street NW (Broad to Clarendon)

The Ohio Department of Transportation completed a speed study on Village ST SE and based on the results of the traffic and engineering investigation found that 30 MPH is a reasonable and safe speed limit.

Zoning Department

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 219 52nd ST SW- unsecure structure, 3911 Georgetown St NE- no conditional use permit, 910 Bellflower Ave NW- trash/ debris/ unlicensed vehicles, 3970 Faircrest ST SW and 3209 Sandy Ave SE both for trash/ debris.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 22 parcels: 1305102, 1305101, 1305100, 1312336, 1303629, 1303630, 1303631, 1307061, 1307062, 1312902, 1306616, 1301591, 1309342, 1302358, 1303513, 1303235, 1308938, 1307235, 1307233, 1307232, 1314996, 1400236, totaling \$11,100.00

The Board approved an application for reclassification of property from Larry Bowling at 3650 Cleveland Ave SE from a B2- Neighborhood Business District to a B3- Commercial Business District. Stark County Regional Planning and Canton Township Zoning Commission previously reviewed this application at prior meetings and recommended approval of the reclassification.

The Zoning Director updated the Board that all of the junk vehicles at 2347 Prairie College have been removed from the property.
