


October 18th Meeting Highlights

Canton Township Comprehensive Plan

The Stark County Regional Planning Commission (SCRPC) has been working with Canton Township to complete their first comprehensive plan. The plan will help guide growth and development decisions with the identified vision of the residents and administration. SCRPC staff attended various events with the township including trustee and school board meetings and Canton Township Community Day in both 2021 and 2022. Along with attending these events gathering public input, a community survey was also distributed over a three-month period to gather additional feedback.

SCRPC staff and Canton Township officials and administration plan on hosting a public meeting in the fall to present the draft plan to the public. Once public comments are taken into consideration, the plan can be adopted by the township.

Representatives from Stark County Regional Planning presented the draft of the Canton Township Comprehensive Plan. A meeting will be scheduled later in the fall to present the draft to the public. Please email pictures to l.datkuliak@cantontwp-oh.gov

The Board agreed to begin the process to purchase 11 acres, former Walker Elementary property, from Canton Local Schools for \$65,000. This agreement is possible as a government entity to government entity exchange.

The Board accepted and thanked the Canton Township Fire Association for the \$212.94 donation to reimburse wages paid for Safety Day.

Zoning Department

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on (13) parcels: : 1303672, 1315065, 1307588, 1307234, 1307235, 1307233, 1307232, 1305737, 1307061, 1307062, 1380055, 1380056 and 1307886 totaling: \$6,450.00

The Board conducted a public hearing and approved reclassification of property for parcel # 1313137 at Navarre Rd SW from B2- Neighborhood Business to B3- Commercial Business. Stark County Regional Planning and the Zoning Commission recommended approval of the reclassification at their prior meetings.

The Board declared the following property as a nuisance as deemed by the Zoning Director, and order it abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87. 3811 Waynesburg Dr SE for trash and debris.

Public Works Department

The Board of Trustees have entered into an service agreement with Perry Township for two sections of Whipple Ave SW that is split down the center between the two townships. The agreement spells out which entity is responsible for what repairs, maintenance, and replacement items for each section of roadway. In the past Canton Township has performed all the work to these sections of road, but moving forward, Perry has agreed to share the maintenance of this section of Whipple Ave.

Also, the Edward C. Levy Co. has invested in paving a 500 foot portion of Whipple Ave SW and will be maintained in the future by the township.

The Public Works Department was approved to purchase a second used dump truck. Having recently purchased a used 2007 International Dump Truck which is set up and ready to go for the upcoming winter season, this was purchased to replace a 1995 International that is starting to have mechanical issues. This truck was purchased for \$29,500.00. The same dealership called and acquired another truck on trade. The truck is a 2010 International which is also set up and ready to go for winter. The township was able to obtain this truck for \$32,000.00 and it will replace a 1992 International, which is the oldest truck in our fleet. Just as a comparison to purchase a NEW dump truck and set it up with the extras needed for snow and ice control would be in the \$200,000.00 range and have a wait time of close to 2 years.

The 2022 Canton Township Paving Project has been extended until the spring of 2023. Due to our first bids being rejected because of the much higher pricing over the prior year, the township had to rebid the project. Once the rebids came in and the project was awarded to Northstar Asphalt Inc. their schedule for 2022 was full. Northstar asked for an extension of the contract until spring 2023 and provided a schedule. The contract is still in place, however the timeline for project completion has been pushed back. Look for a detailed article in the upcoming Township Newsletter.

The Public Works Department has started to winterize the restroom facility at Faircrest Park. Currently the water fountains on the outside of the building have been completed and will not be able to be used until spring. The restrooms will remain open for as long as possible, weather permitting. Once we hit regular freezing temperatures, the restrooms will be closed until spring.


