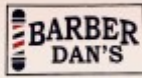

## Fire Department

The Board accepted the resignation of part-time firefighter Noah Denzer effective 11/6/24.

## **Public Works Department**

The Public Works Director gave an update that the crack sealing has been completed on various township roads. Approximately 13,500 lbs of material was used.

The Board approved a one year Memorandum of Understanding for services related to MS4 Stormwater program with Canton Township and Stark Soil & Water.

The Public Works Department will send three employees to the Road Safety Day training hosted by Perry Township.

Two bids were received for the Township Administration office and Public Works Facility sewer project.

1. Bachtel Excavating at \$179,985.00
2. Stanly Miller Construction at \$258,663.00

Bids are being reviewed by The Thrasher Group and a recommendation of award will be provided to the Board of Trustees at the November 19<sup>th</sup> meeting.

Canton Township was contacted about the potential of hosting a 2025 Summer Serenade Concert at the new Amphitheater. This was last done in 2023 and was well attended, despite rain in the forecast and it dropping rain in the middle of the performance.

## **Zoning Department**

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87.4.

The Board approved the Fiscal Officer to sign a letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on (4) parcels 1309242, 1300875, 1301061, and 1306695 totaling \$2,200.00

The Board approved the Fiscal Officer to sign a letter to Stark County Auditor requesting a lien on the tax duplicate for a board-up assessment on (1) parcel 1303261 totaling \$654.00

The Board of Zoning Appeals will conduct a public hearing on Monday, November 18th at 7:00pm to hear the following appeal:

Parcel #1300674- Faircrest ST SW B3- Commercial Business District

Applicant is requesting a conditional use permit to operate as a drive- in establishment for food and beverage sales.

The Board of Trustees will conduct a public hearing on Tuesday, November 19th at 5:30pm to consider recommendations from Stark County Regional Planning and Zoning Commission for text amendment changes to the Canton Township Zoning Resolution regarding the addition of R-4 Low Density Multi-Family and R-5 High Density Multi-Family as a permitted use in B-1 Suburban Office and Limited Business District, B-2 Neighborhood Business District, and B-3 Commercial Business District. Proposed amendments are available for public viewing Mon-Fri from 8am-3pm at the Administration Office.

### **Yard Waste Update**

The Residential Yard Waste site will close for the season on December 1st. The Yard Waste site operations will be closely monitored as we close out the first year of performing under a privatized model. The Board will then assess the final numbers to make determinations on future yard waste operations.
