


## November 23rd Meeting Highlights

## **General Updates**

The township has allotted 128 extra hours specifically dedicated to Canton Township Sheriff's Patrol, funded by the township general fund. To date, 57.5 hours have been worked.

Canton Township received notification, from the Division of Liquor Control, that the liquor license renewal request by Mark & Frances Mills dba Musical Inn (aka The Cove) located at 3941 Navarre Rd SW has been rejected and denied. The business will have 30 days to file an appeal of the decision.

### Fire Department

The Board approved to hire and the swearing in of Brian Hull as a part-time Firefighter/ Medic.



Congratulations!

The Board approved the promotion and swearing in of Sage Ward from part- time to full- time Firefighter/ Medic.

The Board approved the Fire Chief to apply for the Assistance to Firefighters Grant in two separate applications; one grant submission is for the cost of a replacement squad in the amount of \$268,000 and a second submission is for firefighter equipment totaling \$338,000. If awarded, Canton Township's match would be 5% of the respective grant awarded.

## **Public Works Department**

Board approved to hire Gary Weaver as seasonal winter snow and ice maintenance help in the Public Works Department

The residential yard waste site will remain open for the next two weeks, as leaves fell later this season than usual. Closure date for the site will be revisited in two weeks.

"No Parking" signs have been installed on Navarre Road following a resolution that was passed by the Board of Trustees.

ODOT has notified Canton Township regarding the completion of a speed study on Route 800, which results in the reduction of the speed limit between Mill Street south to 53rd St by 5 MPH. ODOT will be replacing the 45 MPH signs with 40 MPH signs before end of 2021.

The Board was provided with a Faircrest Park construction project update that underground plumbing and electric has been roughed in and the concrete floor in bathrooms poured. Awaiting door frames before block can be started. The sewer permit has been obtained. Trusses have been delivered.

## **Zoning Department**

The Zoning Commission conducted a public hearing on Monday, November

15th at 6:00 p.m. to review a resolution to amend the Canton Township Zoning Resolution brought by the Board of Trustees to include all short term rentals (Airbnb, VRBO, etc.), as a bed and breakfast and to limit districts into which such uses are permitted. The Zoning Commission approved of the red line modifications made by Stark County Regional Planning and recommended approval with modification. The Board of Trustees will conduct a Public Hearing on Tuesday, December 7th at 6:00 p.m. to review the recommendations made by SCRP and Zoning Commission.


